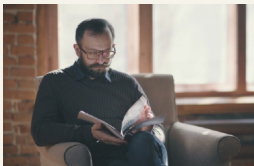

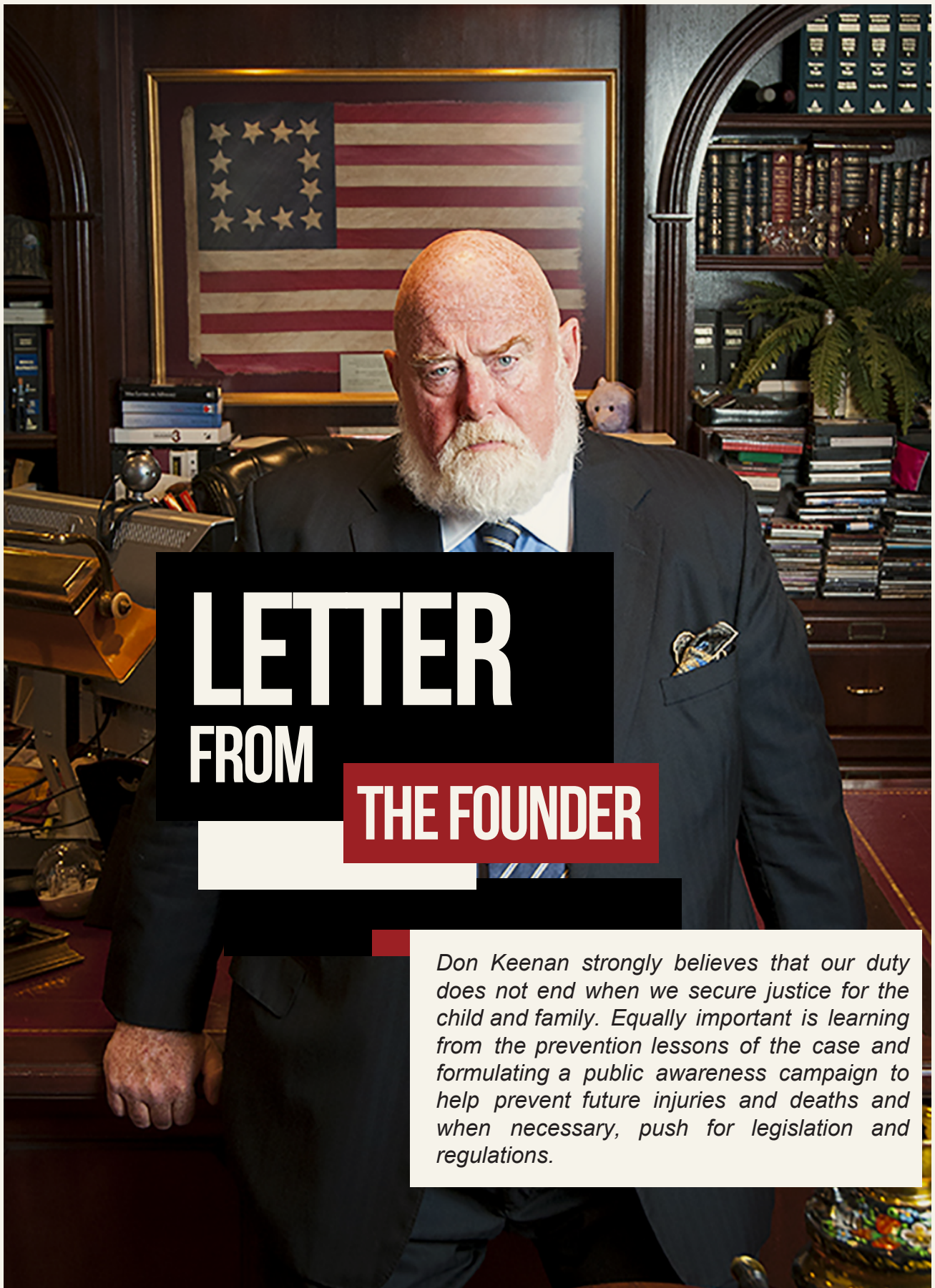

THE DEAN'S PAGE

Message from the Dean

As the Dean of Students for KTI, as a Trial Attorney, as an Advocate, as the Founder of my own practice, and as a partner of Keenan Law Firm I make it a goal (except for COVID year 2020) to try a jury trial every year. October 31, 2022, my client received a verdict in a nursing home wrongful death suit. After fracturing her hip after a fall at home, Kathryn Miller was admitted to a nursing home for rehabilitation. Eleven days into Ms. Miller's rehabilitation, at 8:25 p.m., a certified nursing assistant ("CNA") observed Ms. Miller in distress, "shaking," and "gurgling." The CNA was doing bedtime care for residents on her own even though Ms. Miller required the assistance of at least two people with all activities of daily living. The CNA called for help. A licensed practical nurse ("LPN") rushed to the room and assessed Ms. Miller, who was still breathing. Neither the LPN nor the CNA knew Ms. Miller's code status, so before initiating life-saving measures, the LPN left Ms. Miller and went to the Nursing Station to locate her records and check her code status. When she realized Ms. Miller was full code and never executed a do-not-resuscitate order, the nurse called a Code Blue. CPR started at 8:30 p.m. a full five-minutes after Ms. Miller was observed in respiratory distress. Another LPN responded to the Code Blue and asked: "has anyone called 9-1-1 yet?" Tragically, the answer was "no." Alden Court nursing did not call for emergency services until 8:35 p.m., five minutes after CPR began, and ten minutes after Ms. Miller was observed "shaking" and "gurgling." Policy required for staff to call 9-1-1 immediately. Paramedics arrived and found a large piece of food (bolus) blocking her airway. A timeline demonstrative aid was used to help the jury visualize the significance of these delays.

Ms. Miller was pronounced dead on arrival at the hospital and the matter was turned over to the Commonwealth of Massachusetts Medical Examiner's Office. The Medical Examiner's Office certified the cause of death as "asphyxia, aspiration of food bolus and dementia." The defense argued that the death certificate was wrong but was unable to convince the jury at trial. Ms. Miller was survived by one son who had a very close relationship with his mother and who was a very moving and credible witness at trial. Ms. Miller's daughter and husband, a World War II veteran, predeceased her.

We tried the case as a traditional Systems Failure case. Lack of training, lack of supervision, quality of the staff. We tried the lie, the betrayal, and the hypocrisy. We kept the case simple and used experts the right way. In closing, I reminded the jury that they are the Voice of the Community. (see upcoming blog for more details).

Bottom Line: take what you learn from KTI, imbed it in the case and try your case!

THE JOURNEY

#1: RULES & CASE SELECTION

Rules & Case Selection is the sole entrance to the Keenan Trial Institute. Completing Rules give students the right to attend other KTI courses. Imagine leaving the Rules class with the introduction to an opening statement focused on winning your case in the first four and a half minutes.

DAVID HOEY

David set out to improve the quality of care, and quality of life, in nursing homes through advocacy and litigation. David's mother directed a nursing home for almost 35 years. At a young age, David developed a deep respect for the elderly and felt it was important to preserve their stories. They are the WWI generation that made the country what it is today.

David is considered a pioneer in the field of nursing home abuse and neglect in Massachusetts having obtained the highest verdict for a nursing home death with punitive damages, totaling \$14,447,906.53. This came at a time when Massachusetts did not have voir dire or video depositions, nor was Counsel able to give the Jury a number during closing argument. The law in Massachusetts has since changed, in-part due to David's efforts, and the influence Don had within the Massachusetts area.

David is adamant about preserving the 7th Amendment right to a jury trial. He vigorously contests all attempts at arbitration. Besides nursing home neglect, David has expanded his practice to include catastrophic injury, wrongful death cases, home health care, medical negligence, products liability, transportation vans, auto wrecks, premises liability, defamation cases, and employment.

In July and August 2015, David had the opportunity to try a case with Don. The experience was career changing. The case of Kira Wahlstrom v. JPA Management Services, Inc. et. al. was tried for three and a half weeks. It resulted in a total verdict of \$6,650,829.50. In that case, a young mother was viciously attacked and raped in a Boston hotel parking garage due to the lack of security in the facility. David gained a valuable experience in trying this case with Don, which is shared when he teaches at Trial Management.

Why is David the Dean of KT1? David did what was considered nearly impossible: He successfully obtained verdicts and settlements for elderly people

for elderly people in a jurisdiction that was one of the hardest, if not the hardest, to get a plaintiff's verdict to change the laws, obtained punitive damages, and succeed as a Trial Lawyer. That was important to Don. Don also saw David's passion for the law, his hard work, and his preparation. It goes hand in hand with the motto Amat Victoria Curam. Don and David have a unique friendship and have the utmost respect and trust for each other. 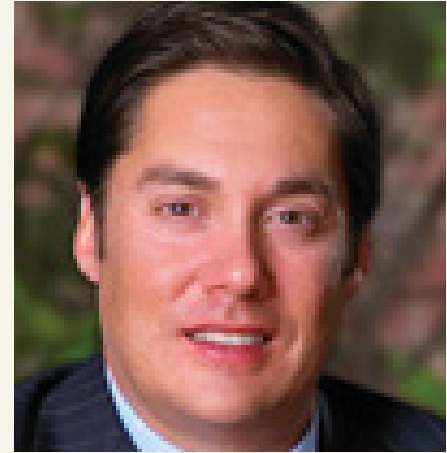

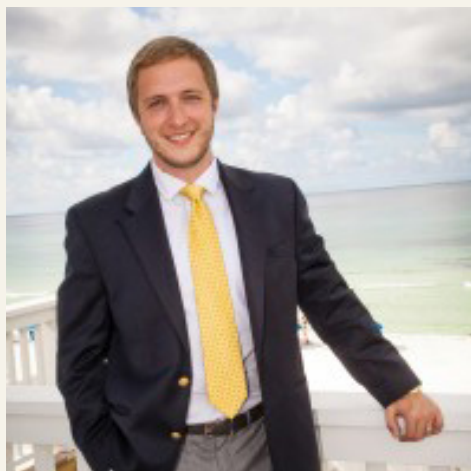

has been to the beach many times for case workshops.

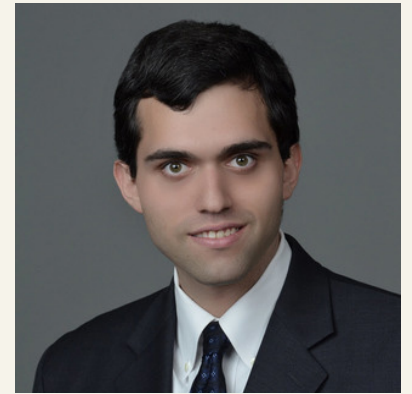


ALEX HOFFSPIEGEL

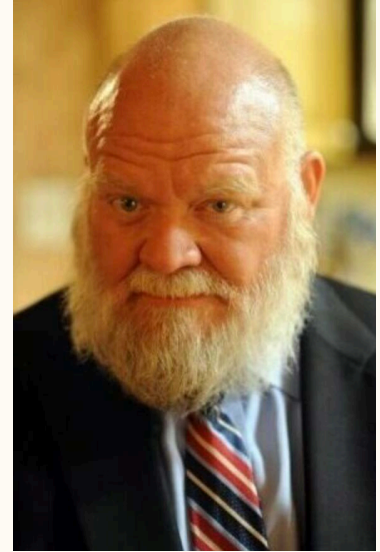


TRAVIS SHETLER

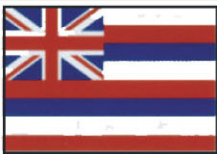

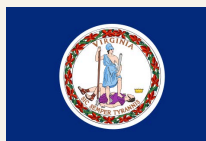

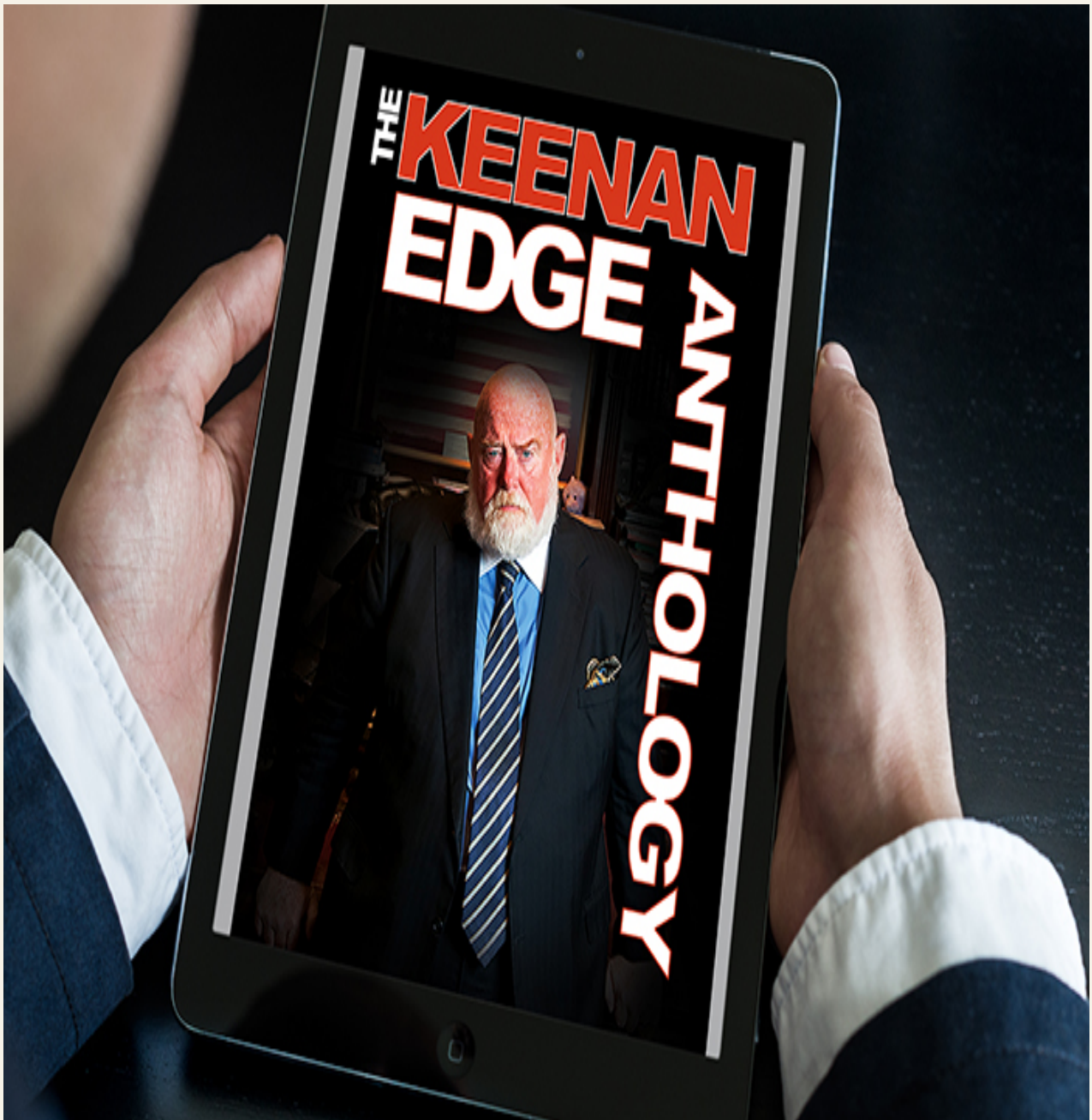
